WITNESSETH: That the Grantor, for and in consideration of the sum of \$10.00 and other valuable considerations, receipt of which is hereby acknowledged, hereby grants, bargains, sells, remises, releases, conveys and confirms unto the Grantee, all that certain land situated in Sarasota County, Florida, described as follows:

DE SOTA PARK, as per Plat thereof recorded in
Plat Book 1, Page 61, of the Public Records of
Sarasota County, Florida.

SUBJECT TO zoning and other prohibitions and regulations imposed by governmental authorities, easements, restrictions and reservations of record that do not prohibit the property from being used for residential purposes, and taxes accruing subsequent to December 31, 1992.


TOGETHER, with all the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining.

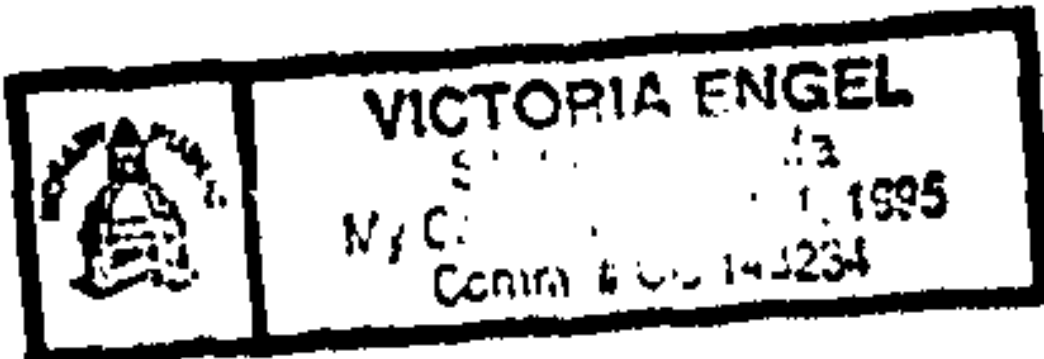

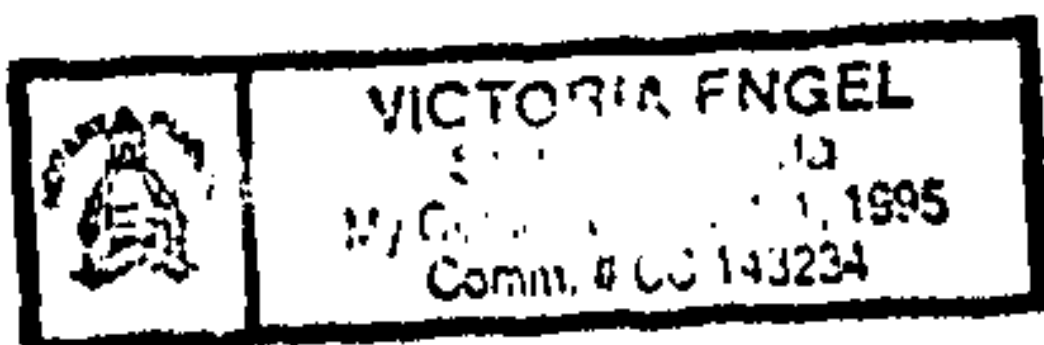
