
Lot 9, GULF GATE, Unit 1, less the West 60' thereof, recorded in Plat Book 13,

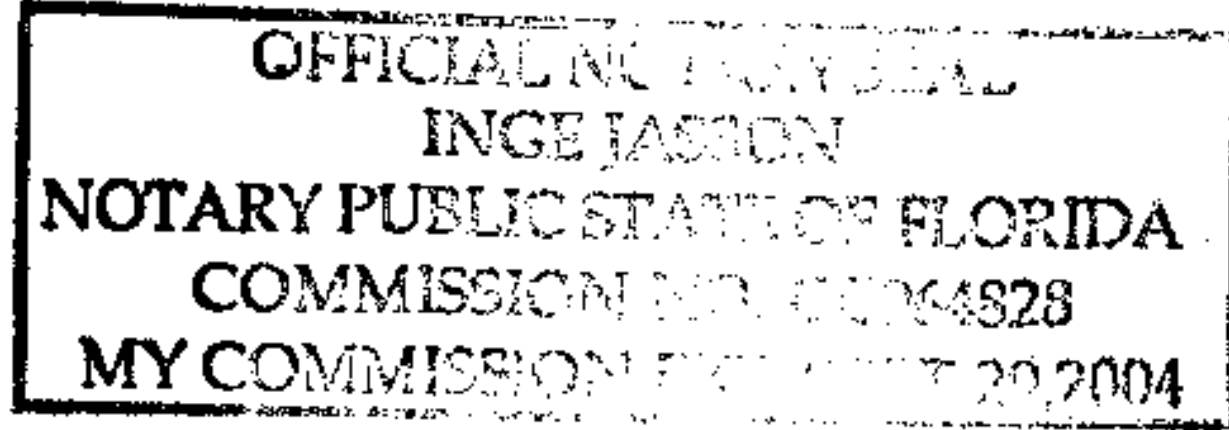
