WITNESSETH: That the grantor, for and in consideration of the sum of \$10.00 and other valuable considerations, receipt whereof is hereby acknowledged, hereby grants, bargains, sells, aliens, remises, releases, conveys and confirms unto the grantee all that certain land situate in Sarasota County, State of Florida, viz:

Lot 11 and the West 1/2 of Lot 13, Block "E", Poinsettia Park, according to the Plat thereof recorded in Plat Book 1, Page 143, of the Public Records of Sarasota County, Florida.

Subject to valid reservations, restrictions and easements of record.

The subject property does not represent the homestead property of Grantors, nor that of their spouses, nor is it contiguous thereto, as defined by the Florida Constitution.

Together, with all the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining.

To Have and to Hold, the same in fee simple forever.
