WARRANTY DEED

LESS a strip of land along West side thereof 27.69 feet in width at North boundary of said Lot 17, 28.49 feet in width at common boundary between Lots 17 and 18 and 29.29 feet in width at the south boundary of said Lot 18.

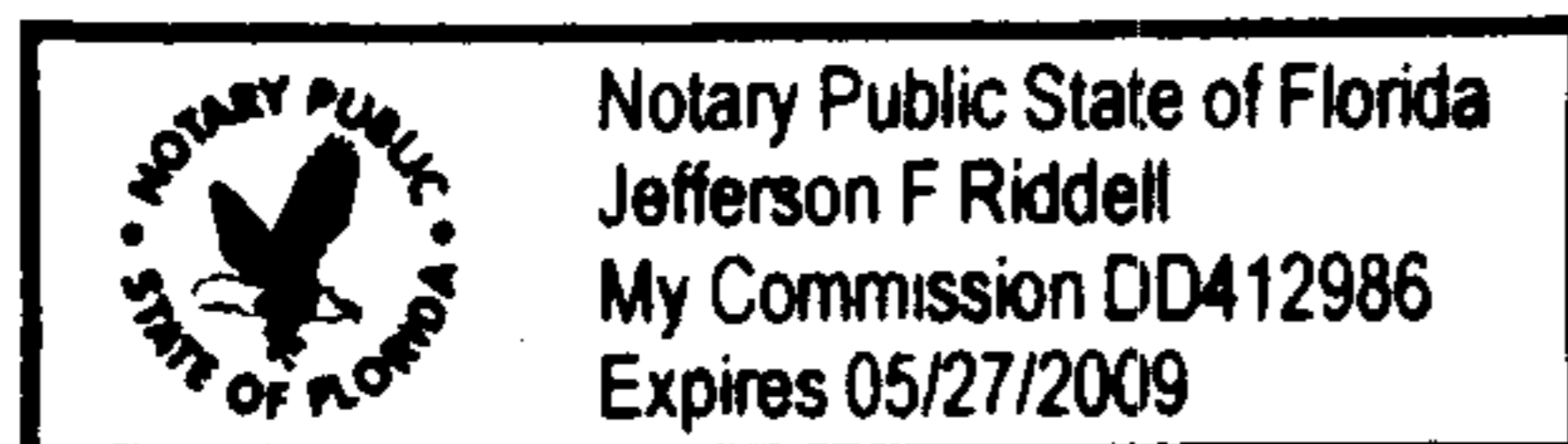
