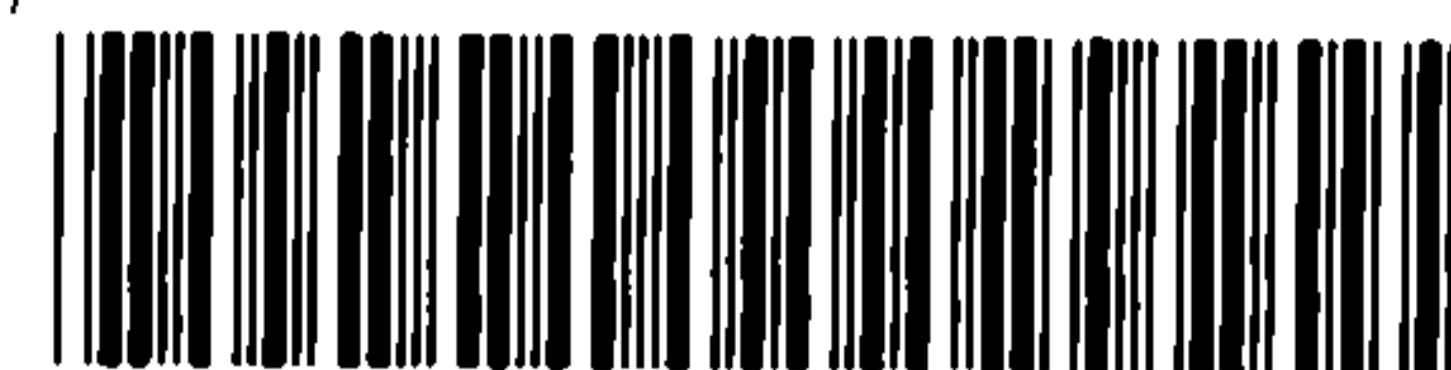

WARRANTY DEED

WITNESSETH: That the Grantor, for and in consideration of the sum of \$10.00 and other valuable considerations, receipt of which is hereby acknowledged, hereby grants, bargains, sells, remises, releases, conveys and confirms unto the Grantee, all that certain land situate in Sarasota County, Florida, more particularly described as follows:

Lot 8, PALEO PARK OF COMMERCE, according to the plat thereof recorded in Plat Book 44, Page 43, of the Public Records of Sarasota County, Florida.

TOGETHER, with all the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining.

TO HAVE AND TO HOLD, the same in fee simple forever.

AND, the Grantor hereby covenants with said Grantee that the Grantor is lawfully seized of said land in fee simple; that the Grantor has good right and lawful authority to sell and convey said land; that the Grantor hereby fully warrants the title to said land and will defend the same against the lawful claims of all persons whomsoever; and that said land is free of all encumbrances, except for that certain Declaration of Covenants, Conditions and Restrictions for Paleo Park of Commerce, as recorded in Official Records Instrument No. 2004205963 in the Public Records of Sarasota County, Florida; other restrictions, reservations and easements of public record; zoning code provisions and other applicable governmental regulations; and taxes accruing subsequent to December 31, 2006, which are not yet due and payable.
