
### Acceptance of Trusteeship

I, John E. Buchman (a/k/a John Edward Buchman), a nominated successor co-Trustee of the William A. Buchman Revocable Trust Agreement, dated August 9, 1973, to William A. Buchman, do hereby state as follows:

1. On August 9, 1973, William A. Buchman created the William A. Buchman Revocable Trust Agreement, dated August 9, 1973 (sometimes hereinafter, the "Trust"), with William A. Buchman as the Grantor and the initial Trustee thereof.
2. Article IV of the Trust Agreement currently governing the Trust provides as follows:
  - "1. In the event of the death, resignation or physical or mental inability of the said William A. Buchman to serve as Trustee, then my Son, John Edward Buchman, and my Daughter, Susan L. Cutter, shall become and serve as Co-Successor Trustees of this Trust."
3. On May 18, 1992, William A. Buchman died.
4. I do hereby formally accept, due to the death of William A. Buchman, the position as Trustee of the William A. Buchman Revocable Trust Agreement, dated August 9, 1973, as well as any separate trusts created or to be created therefrom, and do hereby accept the Trusteeship of said Trust, as well as any separate trusts created or to be created therefrom, in accordance with the Trust Agreement governing the same as currently in effect.


