Butterfield Road, Lombard, IL 60148 and its tax mailing address as **P.O. Box 1450, Chicago, IL 60690-1450** ("Grantee"):

(The terms "Grantor" and "Grantee" include all the parties to this instrument and their respective successors and assigns.)

WITNESSETH: Grantor, for and in consideration of the sum of Ten Dollars (\$10.00) in hand paid by Grantee, the receipt whereof is hereby acknowledged, does hereby remise, release and quit-claim unto Grantee forever, all right, title, interest, claim and demand which the said Grantor has in and to the following described, lot, piece, or parcel of land, situate, lying and being in the County of Sarasota, State of Florida, to wit (the "Property"):

All of Lot 3 and South one-half of Lot 16, Block B, Manasota Land and Timber Co., according to the Plat thereof as recorded in Plat Book A, Page 27, of the Public Records of Sarasota County, Florida, LESS and EXCEPT Road Right of Way for SR 776 (Englewood Road) as described in that certain Stipulation for Entry of Order of Taking recorded in Official Records Book 2741, Pages 166 to 169, inclusive, of the Public Records of Sarasota County, Florida

Subject to all applicable zoning and land use ordinances, covenants, conditions, easements, restrictions and reservations of record; that portion of the property taken for roadway purposes.

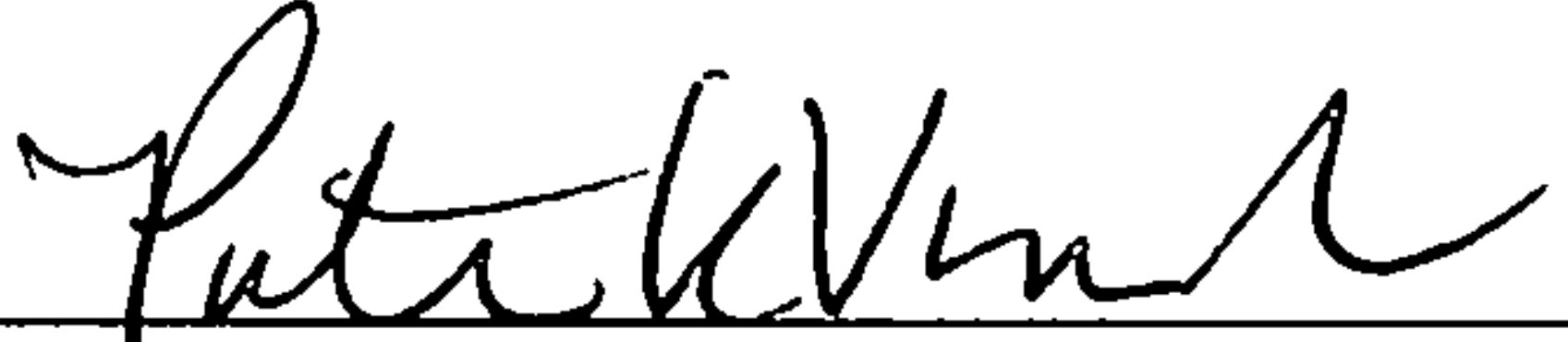
This Property is not now nor ever has been the homestead property of the Grantor.

Sangalis, being the Senior Vice President and Secretary of USA Waste of California, Inc., a Delaware corporation, DO HEREBY CERTIFY as follows:


- (1) the constituent corporations in the merger (the "Merger") are United Waste Systems of California, Inc., a California corporation ("United Waste"), and USA Waste of California, Inc., a Delaware corporation ("USA Waste");
- (2) a Plan of Merger dated as of December 23, 1998 (the "Merger Agreement") has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with Section 252 of the General Corporation Law of Delaware;

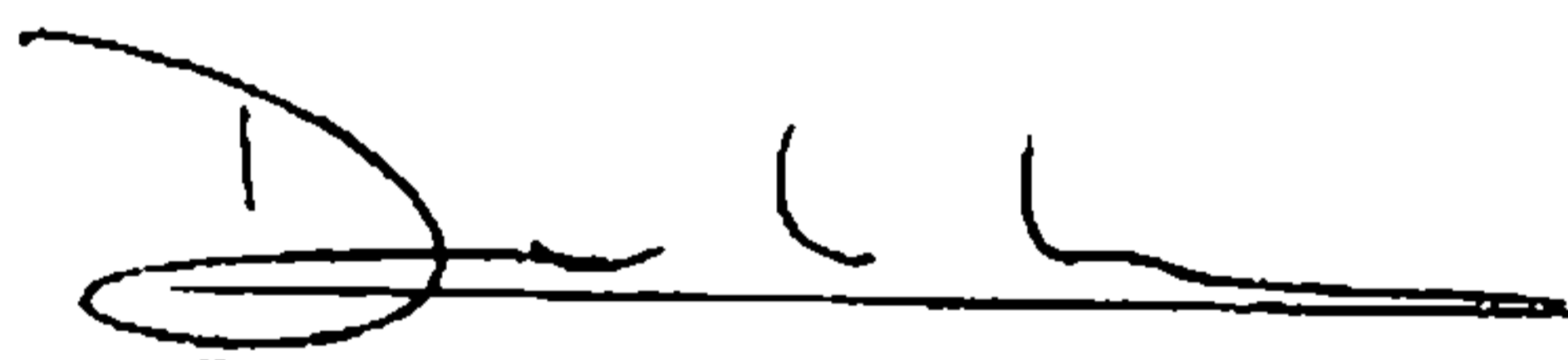
