The Trustee (Grantee) shall have full power to protect, conserve, improve, subdivide, sell, lease, encumber or otherwise to manage and dispose of the real property described in this deed, and the Trustee (and any Successor Trustee of the trust) shall have all of the powers set forth in Sections 689.071 and 737.402, Florida Statutes.

That the said Grantor, for and in consideration of the sum of ten dollars (\$10.00) in hand paid by said Grantee, the receipt whereof is hereby acknowledged, does hereby remise, release and quit claim unto said Grantee and Grantee's heirs, successors forever, all the right, title, interest, claim and demand which the said Grantor has in and to the following described lot, piece or parcel of land, situate, lying and being in the county of **SARASOTA**, State of Florida, to wit:

Lot 15 and the East ½ of Lot 13, Block E, POINSETTIA PARK, according to the Plat thereof, recorded in Plat Book 1, Page 143 of the Public Records of Sarasota County, Florida

Subject to easements, restrictions, reservations, and limitations of record, if any.

Together with all tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining.

To Have and to Hold, the same in fee simple forever.
