Witnesseth, that said grantor, for and in consideration of the sum of TEN AND NO/100 DOLLARS (\$10.00) and other good and valuable considerations to said grantor in hand paid by said grantee, the receipt whereof is hereby acknowledged, has granted, bargained, and sold to the said grantee, and grantee's heirs and assigns forever, the following described land, situate, lying and being in Sarasota County, Florida, to-wit:

A SEVENTY-FIVE PERCENT (75%) INTEREST IN THE FOLLOWING:

PARCEL 1:

The South 220 feet of the North 320 feet of Lot 68, PLAT OF ENGLEWOOD, as per plat thereof recorded in Plat Book A, Page 29, of the Public Records of Sarasota County, Florida, Less the Right-of-Way for State Road 775.

PARCEL 2:

The North 100 feet of Lot 68, PLAT OF ENGLEWOOD, as per plat thereof recorded in Plat Book A, Page 29, of the Public Records of Sarasota County, Florida.

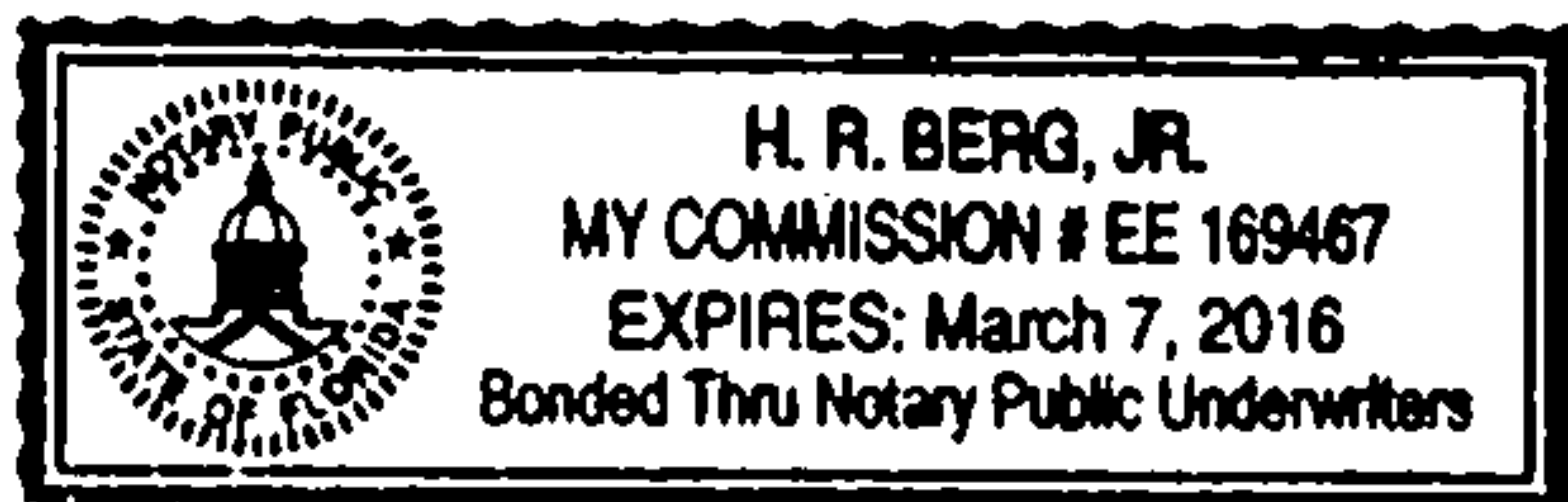
