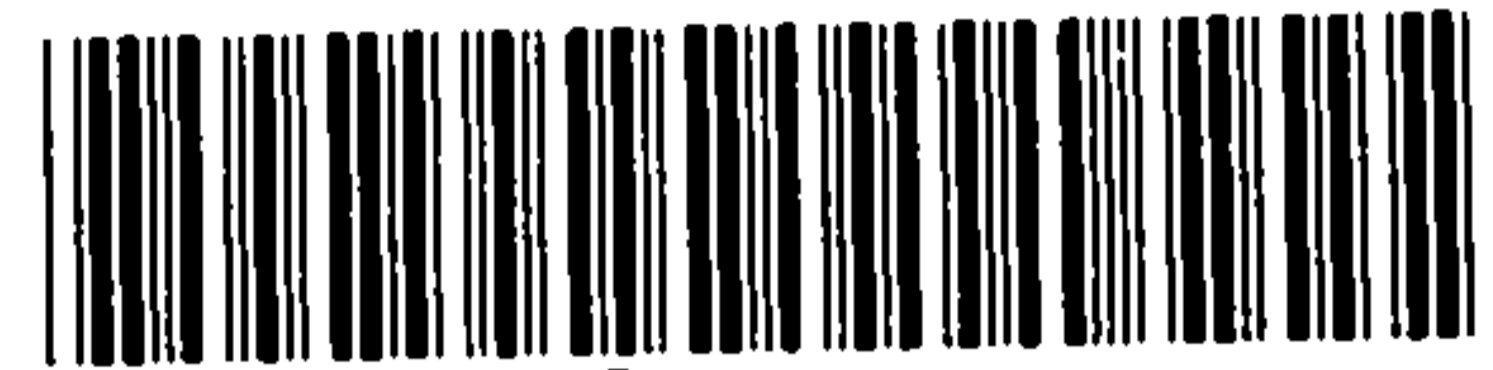

QUITCLAIM DEED

THIS QUITCLAIM DEED, made this 24 day of January, 2014, between **Marjorie L. Albrecht, as Personal Representative of the Estate of Ronald Wilbur Albrecht, individually, and as Co-Trustee of the Roland W. Albrecht Trust dated January 6, 1999, and Penelope E. Miller, individually and as Co-Trustee of the Roland W. Albrecht Trust dated January 6, 1999, and Jay Frederick Albrecht** whose respective post office address are 2679 Novus Place, Sarasota, FL 34237; 4625 Stoneridge Trail, Sarasota, FL 34232; and 9209 Forrester Drive, Bradenton, FL 34202, hereinafter the "**Grantor**," and **Jeffrey Alan Albrecht**, whose post office address is 427 N. Shore Drive, Osprey, FL 34229, hereinafter the "**Grantee**."

(Wherever used herein, the terms **Grantor** and **Grantee** shall include singular and plural, heirs, legal representatives, and assigns of individuals, and the successors and assigns of corporations, wherever the context so admits or requires.)

WITNESSETH, that the **Grantor**, for and in consideration of the sum of Ten Dollars (\$10.00), in hand paid by the **Grantee**, the receipt whereof is hereby acknowledged, does hereby remise, release and quit-claim unto the **Grantee** forever, all the right, title, interest, claim and demand which the **Grantee** has in and to the following described lot, piece or parcel of land, situate, lying and being in Sarasota County, Florida, to wit:

Begin at the NW corner of NE 1/4 of SW 1/4 of Section 20-36-18, thence East along the North line of SW 1/4 (Center line of Fruitville Road), 630.5 feet; thence South 0° 04' West, 40 feet to South line of said Fruitville Road for Point of Beginning; thence continue South 0° 04' West along Westerly line of Lime Avenue (60 feet wide) 131.25 feet; thence South 89° 42' West, 127 feet; thence North 0° 04' East 131.9 feet to South line of said Fruitville Road; thence East along South line of said Road, 127 feet to POINT OF BEGINNING.

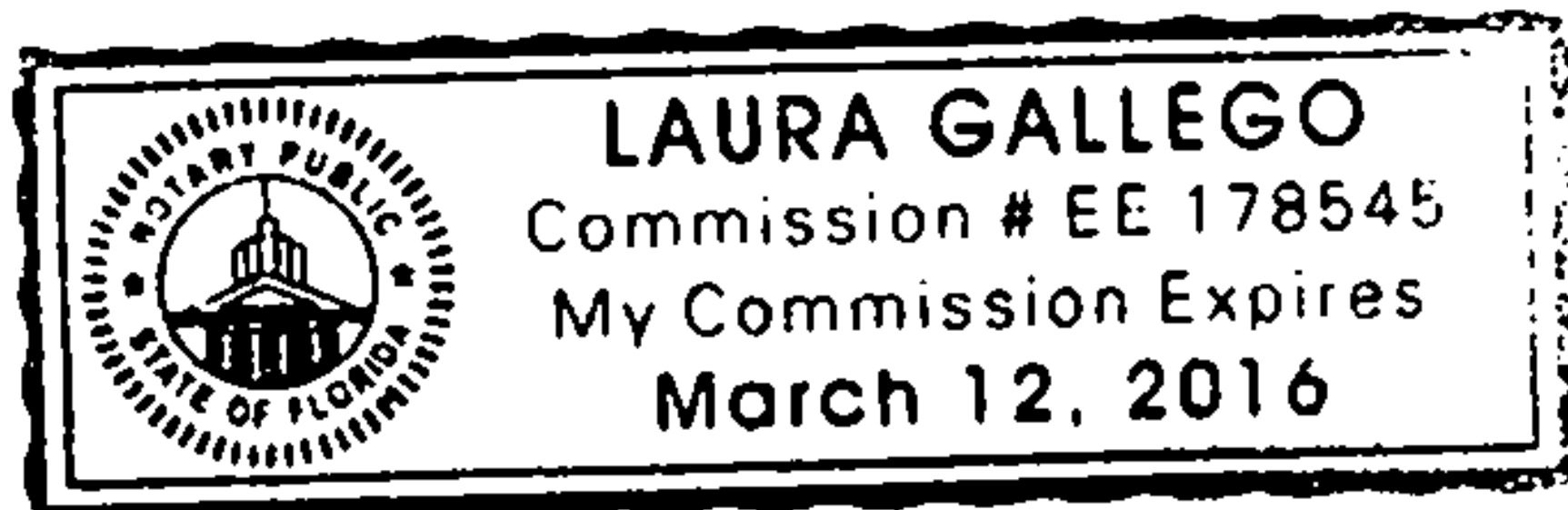
