WARRANTY DEED

THIS WARRANTY DEED, is made this 27th day of March, 2026, by and between **VAN E. HERTEL, JR. AND LORA C. HERTEL, HUSBAND AND WIFE**, whose address is **615 Four Bays Drive, Nokomis, Florida 34275** (hereinafter "GRANTOR"), and **VAN E. HERTEL, JR., TRUSTEE OF THE VAN E. HERTEL, JR. REVOCABLE TRUST DATED FEBRUARY 3, 2003, AND ANY AMENDMENTS THERETO**, as to an undivided Fifty percent (50%) Interest; **AND LORA C. HERTEL, TRUSTEE OF THE LORA C. HERTEL REVOCABLE TRUST DATED FEBRUARY 3, 2003, AND ANY AMENDMENTS THERETO**, as to an undivided Fifty percent (50%) Interest, whose address is **615 Four Bays Drive, Nokomis, Florida 34275** (hereinafter "GRANTEE").

THE GRANTOR, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration to said GRANTOR in hand paid by said GRANTEE, the receipt and adequacy of which is hereby acknowledged, has granted, bargained aliened, remised, released, conveyed confirmed, and sold to said GRANTEE and GRANTEE'S successors, and assigns forever, the following described real property, including improvements thereon, situated in **Sarasota County, Florida**, to wit:

LOT 2, FOUR BAYS SUBDIVISION, AS PER PLAT THEREOF RECORDED IN PLAT BOOK 21, PAGES 17 AND 17A, OF THE PUBLIC RECORDS OF SARASOTA COUNTY, FLORIDA.

Together with appurtenances, privileges, rights, interests, dower, reversions, riparian rights, remainders and easements thereunto appertaining. GRANTOR hereby covenants with GRANTEE that GRANTOR is lawfully seized of said property in fee simple; that it is free of encumbrances except for taxes for the current and subsequent years, easements, reservations, and restrictions of record, if any, which reference thereto shall not serve to re-impose same; that GRANTOR has good right and lawful authority to convey same; and that GRANTEE shall have quiet enjoyment thereof. GRANTOR does hereby fully warrant the title to said property and will defend the same against the lawful claims of all persons whomsoever.

Grantee is hereby conferred with the power and authority to protect, conserve, sell, lease, encumber, convey and otherwise manage and dispose of the above described property pursuant to the provisions of Section 689.073, Florida Statutes.

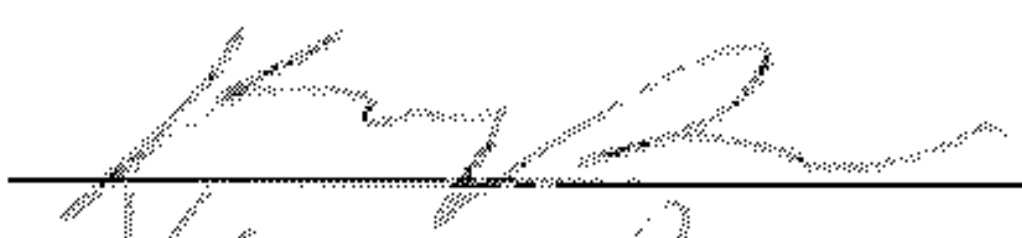
Further, the terms of the trust provide for the present possessory right of possession of any homestead property in accordance with the Department of Revenue Rule 12-D-7.011 and this deed will be recorded in compliance with Section 196.031(1) of the Florida Statutes, thereby entitling any real property transferred to the trust to homestead exemption status if all of the requirements are met.

The subject transaction is exempt from Florida Documentary Stamp Taxes pursuant to Florida Administrative Rule 12B-4.013(28)(a) inasmuch as the subject transaction is a transfer to a trust in which the Grantors hold the sole beneficial ownership.

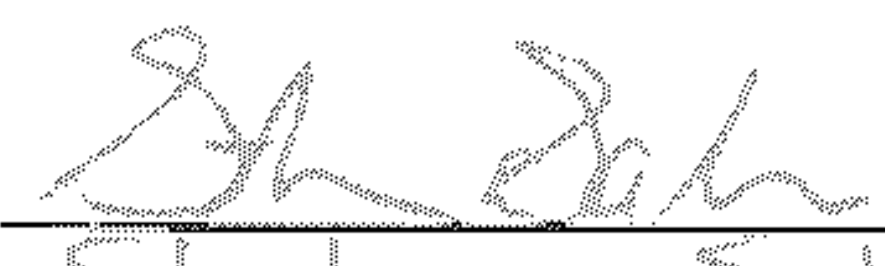

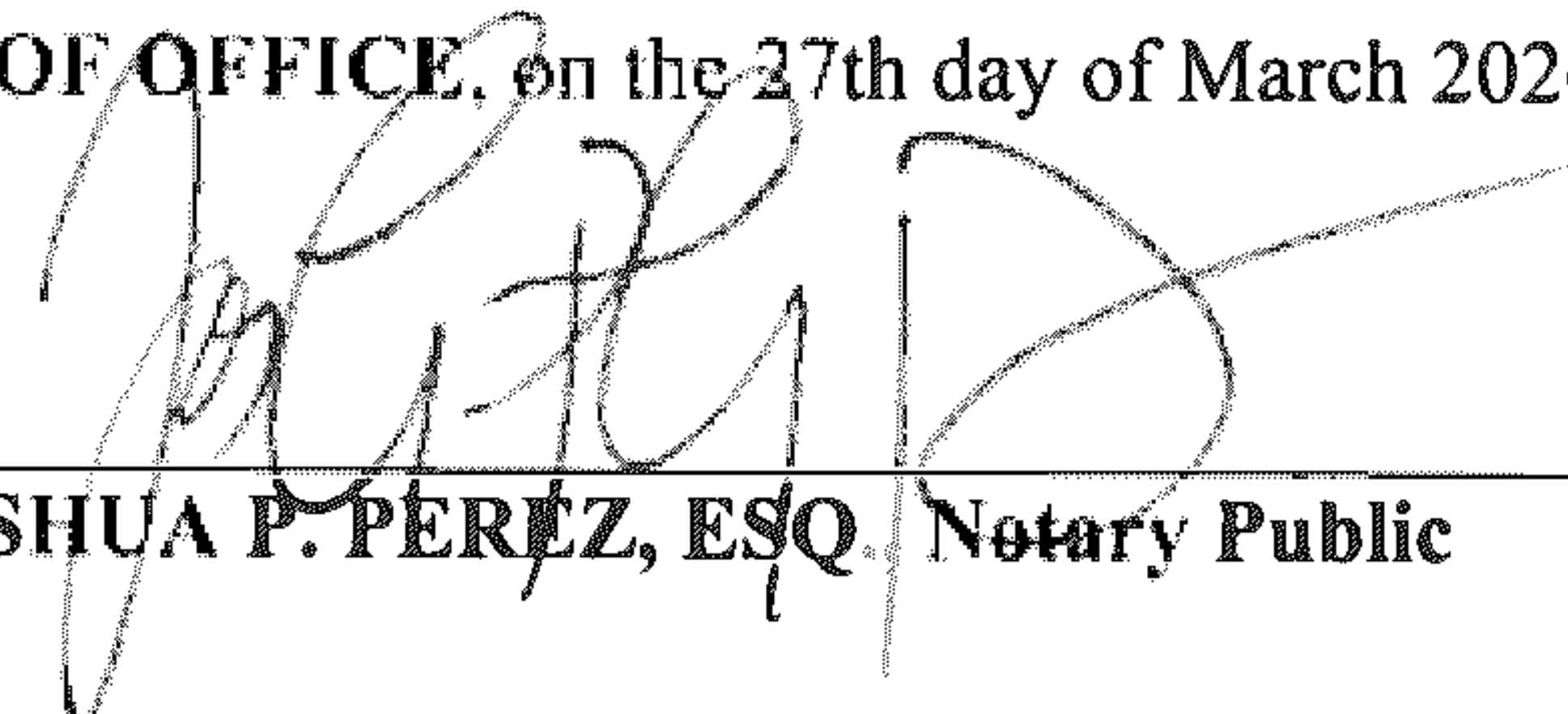
