Grantor, in consideration of the sum of TEN and NO/100 DOLLARS (\$10.00) and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, hereby conveys to Grantee the following described real property in **Sarasota County, Florida**:

***Lot 188, SANDHILL PRESERVE, UNIT 2B, according to the map or plat thereof, as recorded in Plat Book 49, Page(s) 19, of the Public Records of Sarasota County, Florida.***

Subject to valid easements, reservations and restrictions of record, governmental regulations and real property taxes for the current year.

The Trustees shall have the full power and authority as set forth in Florida Statute 689.073, including without limitation to protect, conserve, sell, lease, mortgage, encumber or otherwise manage and dispose of the real property conveyed herein.

The Trustees shall have authority pursuant to the term so the trust to grant a beneficiary right of possession for life sufficient for homestead exemption to **Jeanne M. Cummins**, for the remainder of their life according to Florida Statutes 196.041.

The Trustees shall have no personal liability, and any liability shall be limited to the assets in the Trust. The interest of any beneficiaries of the Trust shall be interests in personal property only.

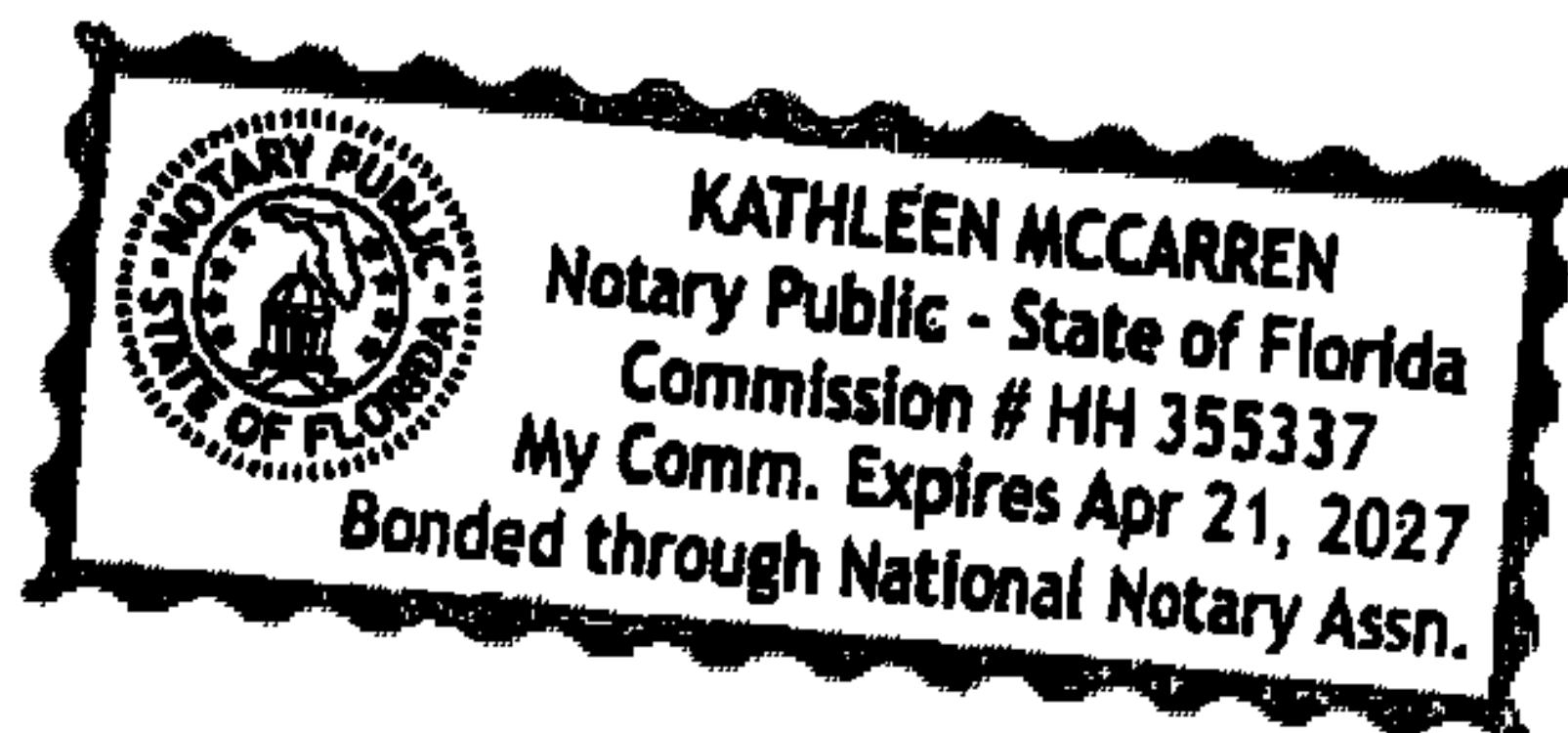
