
Subject to: restrictions, agreements, conditions, easements, covenants and limitations of record, and taxes and assessments for the year 2026 and subsequent years.

Grantor hereby warrants the title to said land, and will defend the same against the lawful claims of all persons claiming by, through or under Grantor.


