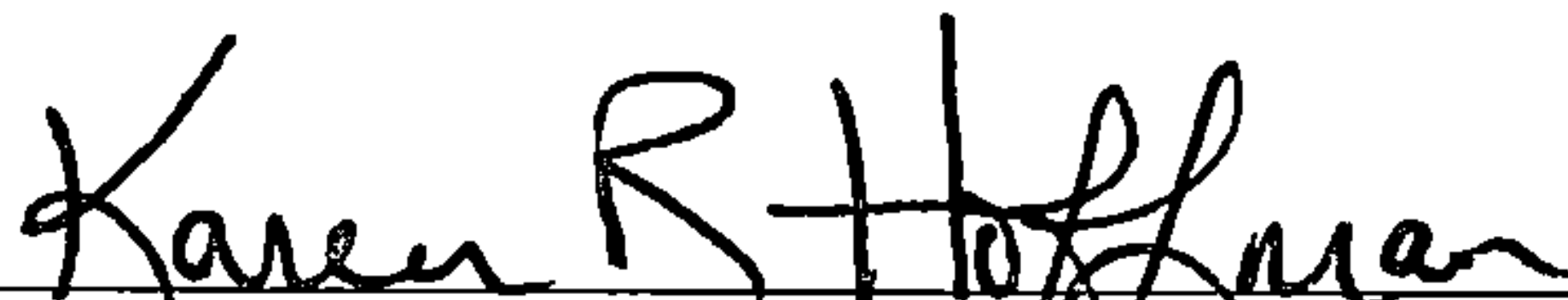

The Grantor confirms that Richard Foster and Janet C. Foster have retained not less than a beneficial interest for life and are entitled to a homestead tax exemption.

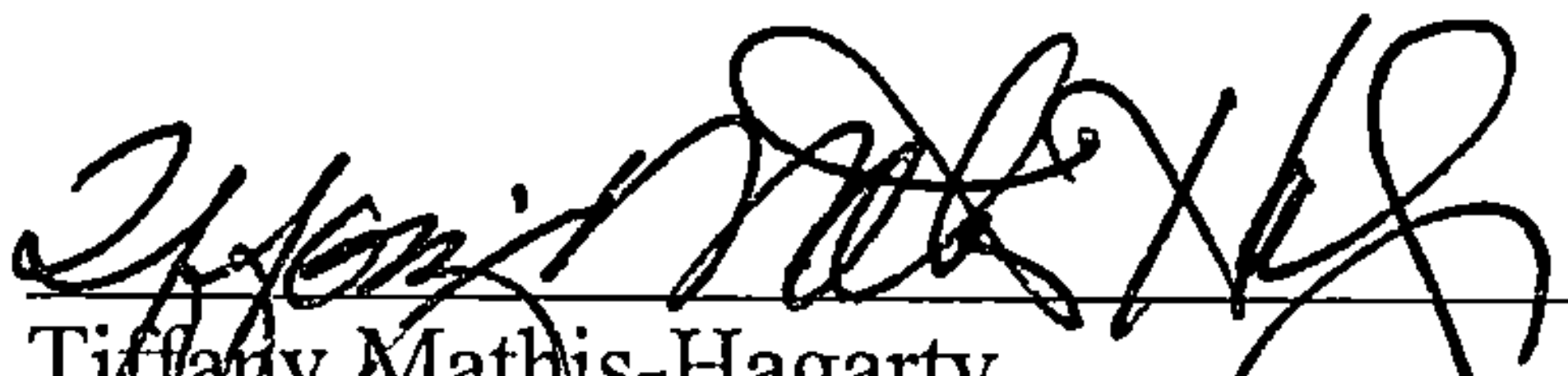
