WARRANTY DEED

TOGETHER WITH all tenements, hereditaments and appurtenances, privileges, rights, interests, reversions, remainders and easements thereunto appertaining.

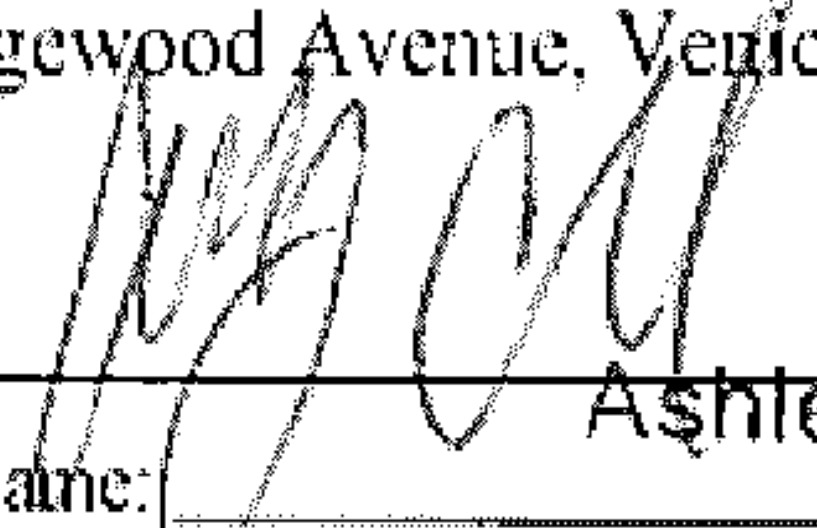

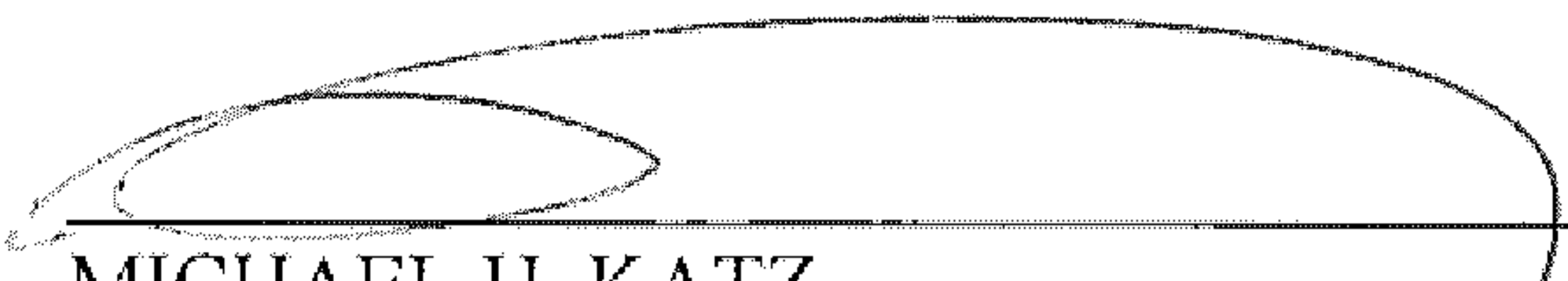
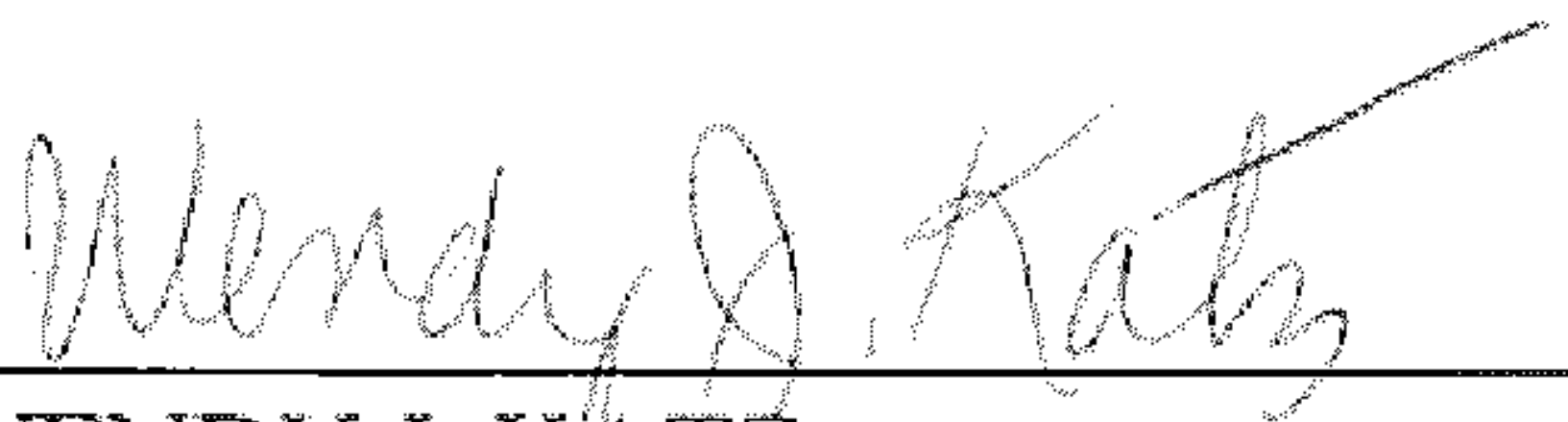
The Trustee is invested with full rights of ownership and is specifically granted the power and authority either to protect, conserve, sell and to convey, or to lease, or to encumber, or

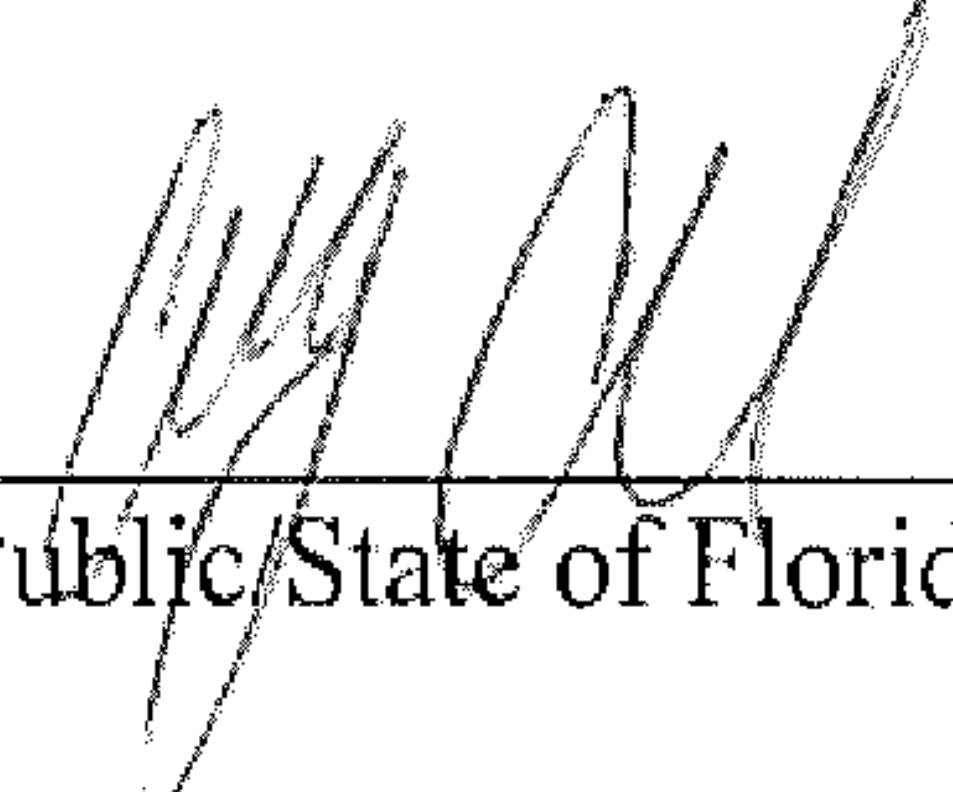
