WARRANTY DEED

as to a life estate interest, without any liability for waste, with full power and authority to sell, convey, mortgage, lease, and otherwise dispose of the property described below in fee simple with or without consideration, including the power to divest the remaindermen of their interest and convey the remainder interest to new remaindermen, without joinder by the remaindermen, and to retain absolutely any and all proceeds derived therefrom. Upon the death of the life tenant, the remainder, if any, in fee simple, to the persons named hereinafter in the fractional shares set forth beside their names as follows: as to an undivided fee simple interest to FARIS FARID FARAGALLA a/k/a FRED FARAGALLA, whose address is 2661 Egypt Mountain Road, Kittrell, NC 27544.

TOGETHER with all and singular the tenements, hereditaments and appurtenances belonging or in anywise appertaining to that real property.

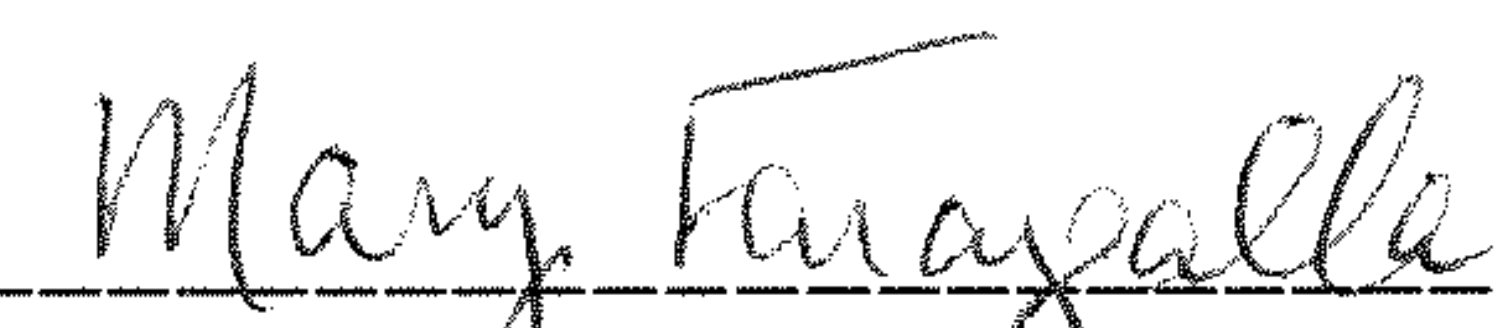
TO HAVE AND TO HOLD the same to the Grantee, its heirs and assigns, in fee simple forever.

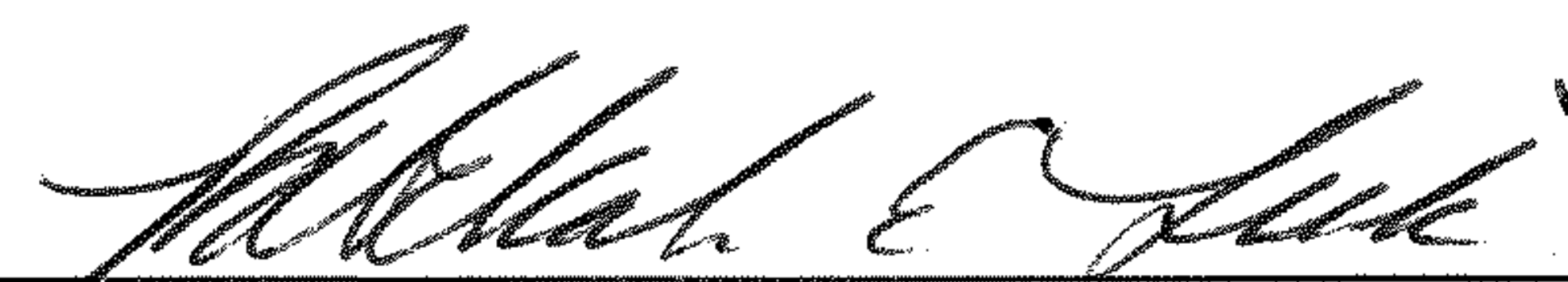
